AIG General Launches Driver Management System Referral Service to Help Corporate Policyholders Comply with Revised Road Traffic Act
Service Responds to New Sobriety Check and Recordkeeping Requirements

TOKYO, March 3, 2022—AIG General Insurance Company (AIG General) is launching free referrals to a driver management system — the “Daily Report & Alcohol Check Record” application — that is designed to help corporate customers comply with amendments to the Road Traffic Act that take effect on April 1, 2022. The service provided by the application is available for free or at a reduced monthly rate¹ to corporate customers with automobile insurance policies from AIG.

As of April 1, the newly amended Road Traffic Act will require commercial vehicle fleet safety managers to visually confirm that all drivers are sober when beginning and ending their shifts. From October 1, visual sobriety checks will be replaced with breathalyzers. Companies will also be required to store sobriety check data for a period of one year. The Traffic Act amendments also expand the scope of sobriety tests beyond vehicles with green license plates (used by companies in the transportation and logistics sector) to include vehicles with white license plates used for business.

At a time when fleet managers are facing a significant increase in the amount of information they will be legally required to collect and preserve on a daily basis, an AIG General survey of companies that fall under the scope of the amended law indicates that approximately half of the respondents were either unaware of or not yet in compliance with the new requirements². Creating a system for properly managing the increased information tracking burden is a critical issue for any company seeking to effectively manage its corporate risk exposure. To help companies and fleet managers better implement, manage and track the required sobriety check and recordkeeping process, AIG will introduce the Daily Report & Alcohol Check app free of charge to any interested corporate automobile insurance policyholders.

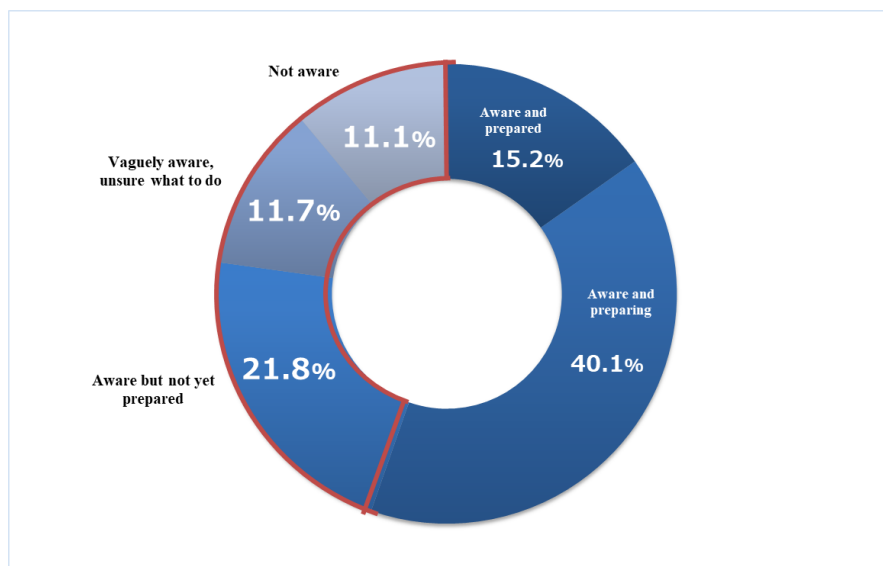

AIG General surveyed owners and managers of 1,030 small and medium-sized companies who are in charge of commercial vehicle fleets subject to new reporting requirements under the amended Road Traffic Act. Survey results indicate that about half of the respondents either had not yet responded to or were not aware that the new regulations (under which companies are required to conduct driver sobriety checks before and after each shift) will be implemented in stages from April 2022.
